OSHA Lead Package, General

- Personal Protective Equipment Selection and Training (29CFR1910.132(f))
- Written Hazard Communication Program (29CFR1910.1200(e))
- Hazard Communication Training Program (29CFR1910.1200(h))

Approximate cost range: \$2,500-\$6,000 plus travel expenses. Estimated one to two days on your site.

Note: We do not currently offer the Respiratory Protection Program as part of Personal Protective Equipment Selection and Training.

OSHA Lead Package, Testing

- Initial Determination for Lead (29CFR1910.1025(d)(2))

Approximate cost range: \$2,000-\$4,500 plus travel expenses. Estimated one day on your site.

Note: Several Initial Determination for Lead tests may be required.

OSHA Lead Package, Initial

- Lead Training Program (29CFR1910.1025(l)(1)(i))
- Housekeeping Program Development and Documentation (29CFR1910.1025(h))

Approximate cost range: \$2,500-\$5,000 plus travel expenses. Estimated one day on your site.

OSHA Lead Package, Annual after Initial

- Lead Training Program (29CFR1910.1025(l)(1)(i))

Approximate cost range: \$1,500-\$4,000 plus travel expenses. Estimated one day on your site.

OSHA Sound Package, Initial

- Sound Pressure Level Determination (29CFR1910.95(b)(2)(1))
- Sound Survey of Non-Range Areas (29CFR1910.95(a))
- Hearing Conservation Program (29CFR1910.95(c))
- Hearing Conservation Training Program (29CFR1910.95(k))

Approximate cost range: \$4,000-\$6,500 plus travel expenses. Estimated one day on your site.

Note: Clinical services and program management are not included.

OSHA Sound Package, Annual after Initial

- Hearing Conservation Training Program (29CFR1910.95(k))

Approximate cost range: \$1,500-\$4,000 plus travel expenses. Estimated one day on your site.
